### 7<sup>th</sup> WORLD CONGRESS OVERVIEW

Wow! The CTBUH 7<sup>th</sup> World Congress was a smashing success by all accounts - starting with a bang and finishing strong. Ole Scheeren, from the Office of Metropolitan Architecture, opened the Congress by challenging the premise of the traditional high-rise....asking, is pursuing height the only ambition? The Congress culminated with a presentation by Larry Silverstein, David Childs, Kenneth Ringle, Charles Maikish, and Stephan Pryor detailing the plans and progress for the redevelopment of Lower Manhattan.

Between these two bookends, a literal encyclopedia of state-of-the-art knowledge was shared by architects, engineers, owners, contractors and specialists from around the world. Notable presentations included the project teams from Taipei 101 and The Burj Dubai, providing detailed reviews of their record-setting buildings. In addition Craig Gibbons of Arup provided an overview of the latest structural engineering including details of the CCTV project in Beijing. The list of notable presenters goes on and on. In total, 400 professionals representing 25 nations participated in this three-day event.

Other highlights of the Congress included the awards dinner which featured a tribute to our beloved friend Norman Kurtz, presentation of the Fazlur Rahman Khan Medal to Dr. Werner Sobek, and presentation of the Lynn S. Beedle Achievement Award to Dr. Alan Davenport. An exhibition, including 25 booths, provided the delegates with additional take-home value during the breaks and lunch each day.
